## Awarding of bid for the Township's 2020 Street Resurfacing Project

There were two bids received for this project. As read at the Workshop meeting, one was from Gessler in the amount of \$292,000 and the other from Sucher at \$248,600. Prior to voting on this item, Engineer James MacCombie stated that there was a mathematical error in one of the bids. Sucher did not include one of the listed line items in their total calculation (although the item was quoted in the overall bid). Consequently, Sucher's actual amount to do the project totaled \$282,699. This was still the lower bid by approximately \$10,000. The streets to be included in the project are: 1<sup>st</sup> Avenue between South and North Governor Printz Blvd. 3<sup>rd</sup> Avenue between Seneca St. and N. Governor Printz Blvd. 5<sup>th</sup> Avenue between S Governor Printz Blvd and Powhattan Ave. Commissioner Arthur asked that any other bids submitted by Sucher must be complete and accurate to be considered for award.

**ON A MOTION** by Mr. Arthur, seconded by Mr. Joseph, the Board voted unanimously to award the bid for the Township's 2020 street resurfacing program to Joseph E. Sucher, Inc. Said bid is in the amount of \$282,699.00 and has been reviewed by the Township Engineer.

## Summer Seasonal Employees

ON A Motion by Mrs. Edmiston, seconded by Mr. Barr, the Board voted unanimously via roll call vote to hire Michael Connor of Lester as a part time seasonal employee beginning in June 2020 at an hourly rate of \$9.25.

## Adoption of Resolution 2020-004 Implementing Provisions of Act15 of 2020

**ON A Motion** by Mr. Joseph, seconded by Mr. Barr, the Board voted unanimously via roll call vote to adopt Resolution 2020-004 relating to Act 15 of 2020 and Property Tax Relief. Said Resolution would extend the period in which the Township will extend a 2% discount on the taxes imposed on real property through June 12, 2020, the "face" value of taxes through September 30, 2020, and the "penalty" amount from October 1 to December 31, 2020.

### **General Obligation Notes Series 2021**

**ON A MOTION** by Mr. Barr, seconded by Mr. Joseph, the Board unanimously voted via roll call vote to advertise an Ordinance to Authorize the Incurrence of Non-Electoral Debt by the issuance of General Obligation Notes 2021 Series in the aggregate principal amount of \$8,121,000 and award a transaction under a Qualified Interest Management Agreement. The 2021 Note Series will fund a certain refunding project consisting of the current refunding of General Obligation Bonds, 2016 B Series to reduce the total debt service payments and payment of the costs of Issuance of the Participant Note.
