Adoption of Township Resolution 2020-005 - Outdoor Dining

Appointment of General Bond Counsel

ON A MOTION by Mr. Barr, seconded by Mr. Joseph, the Board unanimously voted via roll call vote to appoint the law firm of Raffaele Puppio to represent Tinicum Township on the issuance of Township General Obligation bonds of 2021.

<u>Advertisement of Township Ordinance No. 2020-908 Authorizing Nonelectorial Debt and</u> General Obligation Notes of 2021

ON A MOTION by Mr. Barr, seconded by Mrs. Edmiston, the Board unanimously voted via roll call vote to adopt Ordinance No. 2020-908 of the Township of Tinicum, Delaware County, Pennsylvania authorizing the incurrence of non-electoral debt in the aggregate principal amount of \$8,130,000.00; approving certain refunding projects; accepting loan commitment submitted by Delaware Valley Regional Finance Authority; together with fess not exceeding \$40,650.00; approving loan documents and authorizing the execution, delivery of all necessary documents; and pledging the full faith credit and taxing power of the Township to guarantee timely payments of all amounts due and payable under the Participant Note and the Loan Agreement; and any other actions reasonable and necessary to perfect the intended purpose of the Ordinance.

Advertisement of Ordinance 2020-909 Amending and Supplementing Chapter 181 Hotels, Motels and Inns

ON A MOTION by Mrs. Edmiston, seconded by Mr. Joseph, the Board unanimously voted via roll call vote to instruct the Township Solicitor to draft and advertise proposed Ordinance 2020-909 to vacate, amend and/or supplement the Code of Tinicum Township Chapter 181 Hotels, Motels and Inns, providing for further regulation, inspection and licensing procedures for hotels, motels and Inns within the Township.

Waiver of Land Development for Jet Stream Parking to Place a Temporary Office Trailer

ON A MOTION by Mr. Barr, seconded by Mr. Arthur, the Board unanimously voted via roll call vote to waive Land Development requirements for Jet Stream Parking to place a temporary office trailer at their facility at 930 Second St. Said trailer will be to assist Jet Stream in implementing "valet" parking. Trailer size shall not exceed 48' x 24' for a period of not longer than 9 months, pending a written request for an extension. Further the trailer will be subject to all permitting requirements of the Township.

Denial of the Land Development Application of 1 Hotel Group and 101 / 103 Taylor Avenue

Prior to voting on this issue, the Township Manager stated that the Township had reached out to the applicant for an extension both via telephone and in writing. The Township was unable to obtain a response prior to the Commissioner Meeting. The Township Engineer stated that the Application currently does not meet the Zoning Requirement of Chapter 395-17a (51), 395-17d, and 395-30. The Board of Commissioners is not empowered to approve a Land Development Application that does not meet Zoning. Consequently, since the application is not ready to be considered favorably and their time frame is expiring, the Board has determined to deny the application.

ON A MOTION by Mr. Barr, seconded by Mr. Joseph, the Board unanimously voted via roll call vote to deny the Land Development Application of 1 Hotel Group / PHL AT LLC's construction of 2 hotels and its associated improvements at 101 / 103 Taylor Avenue. Said denial is as a result of the project not meeting Zoning, Chapter 395, subsections pertaining to Area and Bulk Lot requirements, Screening, Landscaping, and other sections of Chapter 395 and absent an extension request from the Applicant.

Extension of Time for the Land Development Application of Michael Saltis of Tidal Waters Properties, Poulson Avenue

ON A MOTION by Mr. Joseph, seconded by Ms. Edmiston, the Board unanimously voted via roll call vote to approve the applicants request for a time extension by which the Board must consider Michael Saltis' Tidal Waters Properties land development application. Said land development application is to construct a warehouse on Poulson Ave with related parking and other site features on currently vacant lots. The extension shall until December 31, 2020.

As you are aware I also serve as the Tinicum Township Fire Company Treasurer and as such there was additional activity with securing adequate numbers of personal protective equipment for the fire and ambulance personnel during the pandemic.

In the beginning of March while surveying work around the airport I was stopped at a traffic light on Island Road at Penrose Avenue with the Fire Marshal's Vehicle when I was struck in the rear by an uninsured and unregistered vehicle with an expired vehicle inspection. The damaged buckled the rear of the Fire Marshal's Vehicle doing frame damage. The insurance company totaled the Fire Marshal's Vehicle. I was not injured. However, the loss of the vehicle has created a problem with the equipment that is necessary for fire scene investigations
