### Appointments to Board of Health

### Summer Employee Applications

## **Tinicum Township 2016 Street Repaving**

**ON A MOTION** by Mrs. Edmiston, seconded by Mr. Arthur, the Board voted unanimously via roll call vote to instruct the Township Engineer's office to develop a Request for Proposal for Tinicum Township's 2016 street repaying project. The Township Engineer will provide a proposed list of streets or roads for the Board's consideration in the proposal.

## New Sewage Usage Rate

**ON A MOTION** by Mr. Arthur, seconded by Mr. Barr, the Board unanimously voted via roll call vote to approve the adoption of Tinicum Township Ordinance 880 regulating and amending the rates for annual sewer rental and use. Ordinance 2016-880 will amend the Township's sewer rental rate from \$4.00 per 1000 gallons used to \$4.50 per one thousand gallons used while still exempting the first 35,000 gallons for each semi- annual billing period.

### **Appointment of Lazaretto Bid Committee**

**ON A MOTION** by Mr. Arthur, seconded by Mr. Barr, the Board unanimously voted via roll call vote to appoint a Bid Committee for the purpose of opening any and all bid packages returned to Tinicum Township for the restoration and renovation of the Historic Lazaretto Building. Said Bid Committee will convene on April 7 to open returned bids during a public meeting at 2:15 pm at the Township Administration Office. The Bid Committee will consist of Mr. Dennis O'Neil of MacCombie Engineering, Ms. Nan Gutterman of Vitetta Architects, Ms. Elaine Brolley, Township Secretary, Township Manager David Schreiber, and Commissioner McCarthy.

### Adoption of Employment Agreement with Tinicum Township Non Uniform Employees

**ON A MOTION** by Mrs. Edmiston, seconded by Mr. Arthur, the Board unanimously voted via roll call vote to adopt a Memorandum Of Understanding with the Non Uniform Employees of the Public Works Department and the Wastewater Treatment Plan for a period of three years from 2016 to December 31, 2018. The Memorandum of Understanding calls for salary increases of 3% each year, participating in the Township's healthcare plan with a 2% contribution towards the cost of premium, and participating in a 457 voluntary contribution retirement plan. Said adoption

is contingent upon receipt of a fully executed agreement from the members of the Non Uniform Employees representative members.

### **Appointment of Part Time Police Officers**

**ON A MOTION** by Mr. McCarthy, seconded by Mrs. Edmiston, the Board unanimously voted via roll call vote to appoint Mr. Sal Qualroli of 405 Corinthian Avenue, Essington and Mr. Johnathan Downs of 407 Trites Ave., Norwood to the position of Part Time Patrol Officer within the Tinicum Township Police Department contingent upon the satisfactory completion of a medical and physiological examination.

Mr. James MacCombie reported that his office is reviewing a survey and legal description of Hog Island Road provided by the City of Philadelphia in conjunction with the Township's proposed agreement with the City of Philadelphia for the lease/purchase of Hog Island Road.

## Manager's Report: David D. Schreiber

The Township Manager reported that an advertisement for Requests for Proposals for the restoration of the Lazaretto was advertised and that bids were due by April 7. Mr. Schreiber also reported that the bids for the East Coast Greenway were returned and bids ranged from \$1.8 million to \$2 million. The grant awarded to the Township for the project is \$1.4 million. PennDOT is considering how to cover the additional cost of the project.

### **PUBLIC PARTICIPATION**

### **Public Comment:**

- Mr. John Detwiler, 211 LaGrange, spoke about a mishap at the Essington School on Wanamaker Avenue that happened some time ago and suggested that if the propane tank located at the Clarion Hotel was not properly secured, a similar mishap may occur. Mr. Detwiler also referred to a recent article in the Philadelphia Inquirer that included an interview with the International Airport's CEO. Mr. Detwiler stated that the article reported that the CEP was "put on hold" and that the airport was not going to construct a 5<sup>th</sup> runway.
- 2. Mr. Zurdi Dobi, 200 Powhattan Avenue, stated that the time on the Township's Government Channel needed to be changed by 1 hour. Mr. Dobi stated that the minutes of the January 2016 Reorganization Meeting were not voted upon in a public meeting. Mr. Dobi stated that he received three telephone calls from the Township warning residents about telephone and computer scams. Mr. Dobi complained that no other information was provided to residents about the number of scams perpetrated or the results of an investigation. Mr. Dobi also stated that his Right to Know request from October has yet to be responded to. The Board responded that his request has been responded to.

- 3. Mr. Art Perdun, 247 S. Gov Printz, Blvd., asked if the propane tank located at the Clarion Hotel was temporary. The Board responded it was. Mr. Perdun also spoke about telephone and computer scams that have happened to other people he knows.
- 4. Ms. Marian Matuliwich, 200 Powhatten Ave., stated that her neighbor has a broken drainage pipe on and that water is running onto Ms. Matuliwich's property. The Board responded that the Code Enforcement Officer would look into the problem. Mrs. Matuliwich also stated that there was no crossing guard on the corner of 3<sup>rd</sup> Avenue and Gov Printz Blvd on several occasions and that she called the Police Department to report it.
