Extension of time for Special Use Hearing for Runway 27L Extension

ON A MOTION by Mr. Barr, seconded by Mrs. Edmiston, the Board voted unanimously via a roll call vote to extend the timeframe to conduct a Special Use Hearing for the extension of Runway 27L, at the Philadelphia International Airport approximately 1500 feet until March 16, 2015.

Limited Archaeology Dig at Lazaretto

Before voting on this issue, Mr. MacCombie discussed how prior to building the Township Fire Station, an examination of the property was made with respect to any deceased remains on the property. This was a requirement by the DEP prior to constructing the building. Mr. MacCombie stated that prior to renovating the Lazaretto Building a similar examination of the property would be required for archaeological purposes. Since a University has offered their services to conduct such an examination the Township would not incur the expense of conducting it themselves.

ON A MOTION by Mr. Barr, seconded by Mrs. Edmiston, the Board voted unanimously via roll call vote to permit Dr. David Barnes of the University of Pennsylvania and Dr. Richard Veit of Monmouth University to conduct a limited archaeological dig on the front, or river side, of the Lazaretto Building at the suspected site of the privy pits.

Release #3 to Carr and Duff for Improvements at Intersection of Route 420 and 291

Board of Health / Recreation - January, 2015

Mr. Barr reported that the Board of Health's annual Rabies Clinic will be held on Saturday, April 11 at Town Hall. Residents are encouraged to bring their pets for rabies and distemper vaccines. Mr. Barr also reported that two applications for Health Officer have been received in light of Health Officer Boyle staying home with her newborn child.

Solicitor's Report: Sam Auslander, Esquire

Mr. Auslander reported that an addendum to the memorandum of understanding with Scannell Properties signed in December 2014 was executed in relation to the extension of the sound wall at the Federal Express facility.

Engineer's Report: James MacCombie, P.E.

Mr. Herbert MacCombie reported that the work on the new or second part of the Federal Express sound wall is ongoing, as approximately one-half of the footings have been completed. Mr. MacCombie anticipates a completion date in April 2015.

Mr. MacCombie also addressed a comment made by resident Mr. Kelly at the January meeting where Mr. Kelly opined that the Board had 'no vision' as to improvements within the Township. Mr. MacCombie cited several examples of improvement or economic development including improvements to the exteriors of several hotels in town, the Route 291 beautification project, and several local business establishments in town. Mr. MacCombie noted that there were a number of projects either started or completed in town that would dispute Mr. Kelly's opinion.

Manager's Report: David D. Schreiber

The Township Manager reported that the Township has received word from PennDOT that PennDOT has hired a traffic signal consultant to complete the design work for the school zone lights at the Tinicum School. PennDOT and the consultant will be scheduling a field review over the next week with the goal to have the design reviewed by PennDOT by the end of February.

ON A MOTION by Mr. Barr, seconded by Mrs. Edmiston to adjourn the business portion of this meeting by a unanimous voice vote.


PUBLIC PARTICIPATION
